#### **Regulation for Medical Profession Training for Foreign Doctors in Thailand**

-----

Foreign doctor who requires to have professional training in Thailand needs to follow

### 1. Registration

Applicants need to send their applications at the specified institute according to its regulation.

# 2. Qualification of Applicants

- 2.1 Age 20 years or above
- 2.2 Having obtained degree in medicine (MBBS or MD) from institute recognized by the Medical Council of Thailand. If not yet recognized see detail in Remark
  - 2.2 Holding valid license to practice issued by the country of origin
- 2.3 In good standing and no Freud to profession or in bad conduct which may dishonor to the profession certified by authority of the country of origin within 6 months on the day of training starts
- 2.4 Having passed the qualification test of professional ability and Thai language communicating skill certified by the Royal collage and training institute.
- 2.5 Holding professional insurance issued by a legally Thai certified insurance company of not less than 100,000 Thai Baht.
- 2.6 Fulfil other rules and regulations set up by the Royal college and training institution.

#### Remark

### Recognition Medical schools / Degree

If training medical school of the country of origin is not recognized by the Medical Council of Thailand as listed in our website (See the list in <a href="https://www.tmc.or.th">www.tmc.or.th</a>), the applicant has to submit the request form to the Secretariat Office of the Medical Council of Thailand for consideration and approval

#### 3. Application documents required

3.1 Certified copy of valid medical degree certification or equivalent approved by the Medical Council of Thailand

- 3.2 Certified copy of valid medical license issued by the country of origin and certification of at least 3 years of practice in countries approved by the Medical Council of Thailand.
- 3.3 Certificate of good standing within 6 months validity (up to the day of application) issued by authorized body.
- 3.4 Certificate of professional ability issued by the Royal college and the training institute.
- 3.5 Certificate of ability to use Thai language issued by the Royal college and training institute.
- 3.6 Letter of acceptance from the Chairperson of the council or board of management of the training institute.
- 3.7 Professional insurance of not less than 100,000 Thai Baht issued by the legally Thai certified insurance company.
  - 3.8 Medical health certificate and health insurance.

## 4. Selecting Method

The method of selection will be complied with the rules and regulations issued by the Medical Council of Thailand for Foreign Certification BE 2560.

## 5. Fee for Training

5.1 The fee for training will be 500,000 Thai Baht.

In case of intergovernmental MOU between the country of origin and the Thai Government, the fee will be adjusted according to the agreement made.

- 5.2 Fee foe the examination for certificate will be set by the Medical Council of Thailand.
- 5.3 Other relevant fee, if any, will be complied with the order of the Medical Council of Thailand.

#### Remark

The fees can be flexible according to the decision of the Board of management of the Medical Council of Thailand.
